

ICANN Update on AFRINIC Receiver Appointment

9 March 2025

The African Network Information Centre (AFRINIC) has faced an ongoing crisis of governance. ICANN has been and continues to closely monitor the situation and offers AFRINIC support and advice where we can do so. ICANN is hopeful that the recent developments taken in Mauritius will bring AFRINIC's governance back to a steady state and is committed to ensuring the long-term viability of the RIR system as part of the delivery of ICANN's mission.

ICANN has continued to closely monitor the legal proceedings involving AFRINIC as well as its governance struggles. ICANN notes the Court Order from the Bankruptcy Division of the Supreme Court of Mauritius, dated 12 February 2025. That Court Order names Mr. Gowtamsingh Dabee the newly appointed Receiver over AFRINIC. Mr. Dabee was ordered to expedite the matter to design and conduct elections to reconstitute the AFRINIC Board of Directors by 25 April 2025. The Court acknowledged the powers of the Receiver as provided for under the laws of Mauritius.

ICANN recognizes the important role of the Receiver in repairing AFRINIC's governance and has offered its assistance to Mr. Dabee, as the officially appointed authority designated by the Mauritius' Courts. We previously assisted the Official Receiver of Mauritius in a similar manner.

ICANN has a long-standing and valued relationship with the Internet numbers community. It will continue to closely monitor the situation and provide whatever support the Receiver requests to restore AFRINIC's functional governance and operations.

Dear Members.

By virtue of an Order dated the 12th February 2025, I have been appointed as the Receiver of African Network Information Centre (AFRINIC) Ltd (hereinafter referred to as "AFRINIC") to replace the Official Receiver.

The purpose of appointing a Receiver for AFRINIC is to "hold the ring" and ensure that the status quo of AFRINIC's assets is preserved and that the value of the business is maintained. A Receiver is appointed under Section 178 of the Companies Act 2001 (the "Company Act") and is supported by powers under the Insolvency Act 2009 (the "Insolvency Act").

Given that AFRINIC has not had a quorate Board of directors since June 2022 and has not had any directors since September 2023, I was further mandated by the Supreme Court to see to it that the Board of AFRINIC is reconstituted by way of an election and a Chief Executive Officer is subsequently appointed.

Re: AFRINIC Board Reconstitution Election & Voters Register 2025

I am pleased to inform Resource Members that the election for the reconstitution of the Board of Directors of the African Network Information Centre (AfriNIC) Ltd [hereinafter referred to as 'AFRINIC'] will be held on 23 June 2025 (with e-voting held between 16 June 2025 and 23 June 2025).

Methods of voting

The election will take place in a hybrid format. This means that participating voters will have the option to vote either in person at a designated polling location in Mauritius or online/remotely through a secure digital platform provided by Civica Election Services. The goal of this hybrid approach is to increase accessibility, participation and convenience for all eligible voters while maintaining the integrity and security of the election process.

Voting eligibility criteria (good standing)

Only Resource Members can vote in the election.

A Resource Member must be in "good standing" to vote, meaning, by reference to the Bylaws and the AFRINIC Registration Service Agreement:

- it has completed all the necessary formalities under Article 6.4 of AFRINIC's Bylaws,
- its membership remains current; and
- it has paid all up-to-date membership fees and resource allocation or assignment fees due.

Call for Nominations on the AFRINIC Board is Open

The Nomination Committee 2025 (Nomcom 2025) is pleased to announce the opening of nominations for candidates in the 2025 election for AFRINIC Board of Directors. The Call for nominations for candidates open from 12 to 26 May 2025.

The available seats on AFRINIC's Board of Directors for the 2025 elections are as follows:

- Seat One: North Africa
- · Seat Two: West Africa
- · Seat Three: Indian Ocean
- Seat Four: Central Africa
- Seat Five: Southern Africa
- · Seat Six: Eastern Africa
- · Seat Seven: Region-Independent
- · Seat Eight: Region-Independent

Each seat can only be held by one candidate. A natural person residing in the above sub-regions, as stated, may be nominated for Seats 1, 2, 3, 4, 5 and 6. A natural person from any sub-regions may be nominated for Seats 7 and 8.Elected candidates will serve a three-year term only with respect to Seats 1, 2, 3, 4, 5 and 6 as set out in Articles 13.4(i) and 13.5 of the AFRINIC Bylaws.

Elected candidates will serve a three-year term only with respect to Seats 7 and 8 as set out in Articles 13.4(ii) and 13.5 of the AFRINIC Bylaws.

The Call for Candidates is opened till 26 May 2025 at 23:59 Mauritius Time.

ICANN Calls for Transparency and Fairness in AFRINIC Board Elections

6 June 2025

Today, the Internet Corporation for Assigned Names and Numbers (ICANN) sent a formal notice to the Court Appointed Receiver over the African Network Information Centre (AFRINIC). ICANN calls for immediate action to ensure transparency and fairness in AFRINIC's election process for its Board of Directors.

ICANN's concerns reflect those of many in the AFRINIC community, and focus on two key issues:

- 1. The unique registration of a company as a member of AFRINIC in the Mauritius Corporate and Business Registration Department (CBRD) despite clear inconsistencies with AFRINIC's governance documents and past practices. AFRINIC has over 2,000 resource members, and all of them should have been afforded the same treatment in advance of accepting nominations.
- 2. The appointment of two members to the Nomination Committee who had previously issued an opinion supporting the registration of the same company as a member of AFRINIC.

ICANN is entrusted with ensuring the stable and secure operation of the Internet's unique identifier systems and is responsible for the global coordination of the allocation and assignment of numbering resources. ICANN has a vested interest and role in assuring AFRINIC's return to full operations in alignment with its community-developed policies, and in seeing AFRINIC's governance issues stabilized.

ICANN Obtains Successful Court Ruling, Reinforcing **Call for Fair AFRINIC Board Elections, Court Requires Receiver to make a Communique to Members**

20 June 2025

On 19 June 2025 the Internet Corporation for Assigned Names and Numbers (ICANN) filed an application with the Supreme Court of Mauritius (Bankruptcy Division) and obtained successful rulings on two of its demands of the Court Appointed Receiver over the African Network Information Centre (AFRINIC). This application was submitted to advance ICANN's commitment to AFRINIC holding a swift, fair, and transparent election process to help restore stability and trust to AFRINIC's governance.

This follows ICANN's 6 June 2025 notice to the Court Appointed Receiver over AFRINIC. As previously announced, ICANN's notice focused on the fairness and transparency of the upcoming AFRNIC Board of Directors elections, and specifically demanded that the Receiver take immediate action to:

· Provide AFRINIC members with complete transparency on the status of Resource Members in light of the entry of a member on the Mauritius Corporate and Business Registration Department record.
